5	<p><b>An opportunity for discussion based on any issues residents of the Parish wish to raise</b></p> <p>A MOP reported the use of the designated quiet lane at Church Road by motorbikes who come through at high speed. 07:30 to 12:00 is the time at weekends when the problem occurs.</p> <p>MOP asked about the frequency of grass cutting on quiet lanes. Cllr MG stated that the grass cutting is the responsibility of the County Council and believes that there is no link to the road being designated as a quiet lane.</p> <p>It was noted that speeding traffic appears to be a big problem across the parish.</p> <p>Cllr MG agreed to liaise with Hoxne PC to see if they are experiencing similar problems on their quiet lanes.</p> <p>Anti-social behaviour and crime – series of events recently have taken place in the parish over the past year, which have been reported to the Police.</p> <p>MOP asked about the sewerage at the VH. Cllr Mg confirmed that the Septic tank has been given the all clear. Also asked why the windows haven't been replaced with the same. Not possible as building regulations need to be met and the original windows did not meet these.</p> <p>MOP felt that verges in the parish are being churned up by lorries.</p>
